The Perils of Recycled Annuities

Implications of Settling Claimant's Bankruptcy for Negotiating and Administering Structured Settlements

The bankruptcy of a settling claimant after he or she has been injured can profoundly affect any settlement and the disposition of settlement proceeds, because an injury claim that is unresolved at the time of the bankruptcy, and the proceeds of a claim that has been settled prior to the bankruptcy, automatically become property of the bankruptcy estate and cease to belong to the claimant. In some circumstances a claim arising from an injury occurring after the claimant's bankruptcy also can become bankruptcy estate property. NSSTA counsel Craig Ulman of Hogan Lovells US LLP will explain the applicable bankruptcy law provisions and their implications for claimants, attorneys, settlement consultants, insureds and insurers.
